PROCEEDINGS OF THE ALLENDALE TOWNSHIP BOARD OF TRUSTEES SEPTEMBER SESSION 1ST DAY

The Allendale Township Board of Trustees met at the Allendale Township Auditorium, located at 6676 Lake Michigan Drive, on Monday, September 12, 2022, at 6:00 p.m. and was called to order at 6:00 p.m. by Mr. Elenbaas.

Present at Roll Call: Mr. Zeinstra; Ms. Hansen; Mr. Vander Wall; and Mr. Elenbaas. (4)

Absent at Roll Call: Ms. Kraker; Ms. Vander Veen; and Mr. Murillo (3)

Staff and Guest Present: Sergeant Cal Keuning, Ottawa County Sheriff; Tim Van Bennekom, Finance Director; Greg DeJong, Ottawa County Commissioner; Rebecca Wildeboer; Eric Person; and Lydia Person.

Mr. Zeinstra pronounced the invocation.

Mr. Elenbaas led in the Pledge of Allegiance to the Flag of the United States of America.

- BOT 22-158 Mr. Vander Wall moved to approve the agenda of today as presented. The motion passed.
- BOT 22-159 Mr. Zeinstra moved to approve the following Consent Resolutions:

Public Hearings

1. Truth in Taxation

Mr. Elenbaas opened the public hearing at 6:06 p.m. No comment was received.

Ms. Vander Veen arrived at 6:06 p.m.

BOT 22-160 Mr. Elenbaas moved to close the public hearing at 6:07 p.m. The motion passed.

Public Comments- None

BOT 22-161 Mr. Elenbaas moved to close public comment. The motion passed.

Guest Speakers

Commissioner Greg DeJong provided an Ottawa County update. He requested feedback from the board regarding the Ottawa County Road Commission. He indicated the county was considering whether to assume overseeing Road Commission operations. Commissioner DeJong provided an update on several Parks Department ARPA project requests. Other ARPA project requests included low-income housing in Spring Lake and Holland, and transportation services for veterans. He informed the board that the Ottawa County Health Director, Lisa Stefanovsky will be retiring in March.

Several board members provided feedback on the Ottawa County Road Commission.

Tim Van Bennekom, Finance Director provided a brief overview of the recent and upcoming changes to the budget structure including the creation of capital improvement fund account. He informed the board of money received from the state for revenue sharing. This was a back payment owed due to increased population.

Tim Van Bennekom, Finance Director and Adam Elenbaas, Supervisor

presented proposed budgets for the following accounts:

- BOT 22-162 Mr. Vander Wall moved to approve and authorize the Clerk and Supervisor to sign Resolution 2022-13: Truth in Taxation: Millage Rate; a resolution to approve the levy of an additional millage rate of 0.1232 mills, pursuant to the requirements of the Truth in Taxation Law, and establish the 2022 Allendale Charter Township Allocated Operating Millage rate at 2.7422; and to sign the Ottawa County 2022 Certificate of Compliance form and the 2022 Tax Rate Request form L-4029. The motion passed.
- BOT 22-163 Ms. Vander Veen moved to approve and authorize the Clerk and Supervisor to sign Resolution 2022-14: American Rescue Plan Act (ARPA) Expenditure; a resolution authorizing the use of State and Local Fiscal Recovery Funds (SLFRF)- Revenue Replacement to streamline reporting requirements by expending the SLFRF in an operational capacity for the fiscal years 2022-2026. The motion passed.
- BOT 22-164 Ms. Vander Veen moved to approve and authorize the Clerk and Supervisor to sign Resolution 2022-15: Wage Movement Policy; a resolution establishing annual wage movement considerations. The motion passed.

Resolution 2022-16: Wage Movement for 2022 End of Year Increases. No action was taken.

General Law Ordinance Codification Update- Mr. Elenbaas and Ms. Hansen provided an update on codification and next steps in the final stage of the process.

Mr. Vander Wall would like to have the DDA have a presence on the website.

Mr. Zeinstra indicated he felt the strategic planning session was a great meeting.

Ms. Vander Veen concurred with Mr. Zeinstra's sentiments. She also informed the board that the Friends of the Library had an initial meeting.

Ms. Hansen informed the board of the following grants obtained: Community Events received \$1,440.00 from the Michigan Humanities Counsel for several of this year's concerts; and Elections was rewarded \$7,500.00 in Help America Vote Act (HAVA) grant funds. She also sought clarification from the board on how best to proceed with plans for Allendale's 175th Community Celebration event.

BOT 22-166 Mr. Vander Wall moved to adjourn the meeting at 8:19 p.m. The motion passed.



3. Communications and Correspondence:

Communication was received that the Marcusse Office Building agenda item will be tabled for this meeting.

- 4. Motion by Chapla to approve of the August 15, 2022, Planning Commission Minutes as presented. Seconded by Nadda. **Approved 6-0**
- 5. Motion by Longcore to approve the September 6, 2022, Planning Commission Agenda with the change of striking the Marcusse Office Building from the Agenda. Seconded by Adams. **Approved 6-0**
- 6. Public Comments for *non-public hearing item*:

Chairperson Longcore opened the public comment section for non-public hearing items. No comments were mad, and Chairperson Longcore closed the public comment section.

- 7. Public Hearings: None
- 8. Site Plan Review: None
- 9. New Business:
 - A. 5015 Warner Mining Site Annual Review

Kelly Kuiper presented the report noting that there was only one complaint lodged to the Township regarding the condition of the road and that the complaint was resolved. The mining operation is on track to be finished within the permitted time period.

- B. Griffioen Special Use Request 10259 52nd Avenue
 - Farm equipment storage with incidental repair and service

Owner of the property, Steve Griffioen, presented the project.

Planner Ransford reviewed his memo.

Mr. Westerling asked for clarification on if he would be servicing strictly farm equipment and if it would only be his own or would he seek customers and service their equipment or vehicles. Mr. Griffioen clarified that he would be open to servicing any type of vehicle, not just farm equipment and would seek customers just by word of mouth, but that the repair would not be the primary use.

Planner Ransford explained that the special use would run with the land. If the property would be sold, the purchaser would be able to operate under the special use if it follows the conditions, or if they would want to change it, they will have to come back to the Planning Commission unless it would be a use by right.

Mr. Chapla is concerned that the use would turn to be more commercial that what was intended. Commissioners discussed conditions that could be placed on the approval to deter that from happening.

Chairperson Longcore asked Planner Ransford about the extent of repairs and whether any vehicle could be repaired. Ransford noted that the language limits the incidental repair to the related farm equipment.

It would likely be reasonable for him to repair a truck or other farm related vehicle, but the language is not intended to be a typical vehicle repair shop.

Commissioners discussed the placement of the proposed building and the distance from the road and how that would be allowed under the Zoning Ordinance. They discussed how the rules apply in the Agricultural Zoning District and the Right to Farm Act. Planner Ransford will investigate this issue and ask the Township lawyer for their interpretation.

Commissioners opined that some conditions that could be placed on approval would be:

- No commercial signs.
- Limited parking.
- Barn would stay with the overall property if a split would ever be sought.
- Sidewalk would be deferred until 52nd Ave. is paved.

This project will not be set for public hearing until the interpretation of the ordinance regarding the building placement is received from legal counsel.

C. Zoning Ordinance Text Discussion – Section 23.08 – Removal of Topsoil, Sand, Gravel, or Other Materials

Planner Ransford reviewed his memo regarding the discussion of amending the Zoning Ordinance.

Commissioners discussed options for putting enforcement or penalty language in the approval. They also deliberated what "customary mining operations" means and if any other limitations could be put in place to protect neighbors of these operations.

Commissioners requested Planner Ransford look into what his other townships have, as well as Grand Haven Charter Township, in regard to limitations and if there is anything that Allendale is missing in our ordinance or if we are in line with what other townships have in their ordinances.

Mr. Nadda brought up Station 45, the cars parking on the grass and the cars in the back lot.


Allendale Township Traffic Crashes

Wage Movement for End of 2022 Increases

At a regular meeting of the Township Board of the Charter Township of Allendale, Ottawa County, Michigan, held at the Township Hall located at 6676 Lake Michigan Drive, Allendale, Ottawa County, Michigan on September 12, 2022.

The following resolution was offered by ______ and seconded by ______.

WHEREAS, it is the desire of the Township Board to ensure our residents, businessowners and other stakeholders receive the best service possible.

WHEREAS, the Township Board recognizes that in order to provide the best service we must be able to recruit and retain the best employees possible.

WHEREAS, to recruit and retain the best talent the Township Board understands we must provide competitive financial compensation as part of a competitive employment package.

WHEREAS, to provide competitive compensation the board desires to provide for annual changes in compensation to account for things such as cost of living as well as incentive opportunities to reward exceptional performance

WHEREAS, it is the desire of the Township Board to approve and authorize the implementation of this formula for wage movement for staff.

WHEREAS, all previous resolutions in conflict with this resolution are null and void.

Now Therefore Be It Resolved; the Township Board is implementing the below wage increases to be used in the 2022 year end evaluations and become effective January 2, 2023:

- 1. In <u>2023</u> the top and bottom of every wage range will be increased by 2%. This is based on the recommendation from Human Resources and the Finance Director.
 - a. Note: No employee can earn above the top of their wage range.
- 2. Each employee will receive a year-over-year increase to base wages equal to the amount the wage range increases. For <u>2023</u> this amount is 2%.

- 3. To incentivize for performance, an addition increase of up to <u>3%</u> is available. This component incentivizes and rewards employees for meeting annual goals and exceptional performance.
 - a. This additional increase will be based on the employee's rating that is determined by an annual performance review overseen by the Township Supervisor and Human Resources Director. The evaluation is performed at the end of the 2022 calendar year and becomes effective January 2, 2023.
 - b. Employees at the top of their wage rage are not eligible for any additional increase described in #3.
- 4. This policy will be reviewed annually by the Finance and Human Resources Director annually. They will make a recommendation to the Board on the viability of the policy or if extraordinary circumstances call for special consideration.
- 5. The board maintains the ability to increase/decrease percentage increases based on economic factors.

ORDINANCE NO. 2022-08

AN ORDINANCE ADOPTING A CODIFICATION AND REVISION OF THE ORDINANCES OF THE CHARTER TOWNSHIP OF ALLENDALE, COUNTY OF OTTAWA, STATE OF MICHIGAN; PROVIDING FOR THE MAINTENANCE OF SAID CODE; REPEALING AND SAVING FROM REPEAL CERTAIN ORDINANCES NOT INCLUDED THEREIN; ESTABLISHING A PENALTY FOR ALTERING OR TAMPERING WITH THE CODE; AND MAKING CERTAIN CHANGES IN PREVIOUSLY ADOPTED ORDINANCES

The Charter Township of Allendale ordains as follows:

§ 1-1. Adoption of Code.

The ordinances of the Charter Township of Allendale of a general and permanent nature adopted by the Township Board of the Charter Township of Allendale, as revised, codified and consolidated into chapters and sections by General Code, and consisting of Chapters 1 through 470, are hereby approved, adopted, ordained and enacted as the "Code of the Charter Township of Allendale," hereinafter known and referred to as the "Code."

§ 1-2. Code supersedes prior ordinances.

This ordinance and the Code shall supersede all other general and permanent ordinances enacted prior to the enactment of this Code, except such ordinances as are hereinafter expressly saved from repeal or continued in force.

§ 1-3. Copy of Code on file.

A copy of the Code in loose-leaf form has been filed in the office of the Charter Township Clerk and shall remain there for use and examination by the public until final action is taken on this ordinance; and, if this ordinance shall be adopted, such copy shall be certified to by the Clerk of the Charter Township of Allendale by impressing thereon the Seal of the Charter Township, as provided by law, and such certified copy shall remain on file in the office of the Charter Township Clerk, to be made available to persons desiring to examine the same during all times while said Code is in effect.

§ 1-4. Amendments to Code.

Any and all additions, amendments or supplements to the Code, when passed and adopted in such form as to indicate the intent of the governing body to make them a part thereof, shall be deemed to be incorporated into such Code so that reference to the "Code of the Charter Township of Allendale" shall be understood and intended to include such additions and amendments. Whenever

such additions, amendments or supplements to the Code shall be adopted, they shall thereafter be printed and, as provided hereunder, inserted in the loose-leaf book containing said Code as amendments and supplements thereto.

§ 1-5. Publication; filing.

The Clerk of the Charter Township of Allendale, pursuant to law, shall cause to be published, in the manner required, a copy of this Adopting Ordinance in a newspaper of general circulation in the Charter Township. Sufficient copies of the Code shall be maintained in the office of the Clerk for inspection by the public at all times during regular office hours. The enactment and publication of this Adopting Ordinance, coupled with availability of copies of the Code for inspection by the public, shall be deemed, held and considered to be due and legal publication of all provisions of the Code for all purposes.

§ 1-6. Adoption; when effective.

This ordinance shall be published in the manner as required by law. Except as otherwise provided by law, this ordinance shall be effective on the day after final publication.

§ 1-7. Code book to be kept up-to-date.

It shall be the duty of the Clerk or someone authorized and directed by the Clerk to keep up-to-date the certified copy of the book containing the Code required to be filed in his or her office for the use of the public. All changes in said Code and all ordinances adopted subsequent to the effective date of this codification which shall be adopted specifically as part of the Code shall, when finally adopted, be included therein by reference until such changes or new ordinances are printed as supplements to said Code book, at which time such supplements shall be inserted therein.

§ 1-8. Sale of Code book.

Copies of the Code, or any chapter or portion of it, may be purchased from the Clerk, or an authorized agent of the Clerk, upon the payment of a fee authorized by the Township Board of the Charter Township of Allendale. The Clerk shall also arrange for procedures for the periodic supplementation of the Code.

§ 1-9. Altering or tampering with Code; penalties for violation.

It shall be unlawful for anyone to improperly change or amend, by additions or deletions, any part or portion of the Code or to alter or tamper with such Code in any manner whatsoever which will cause the law of the Charter Township of Allendale to be misrepresented thereby. Anyone violating this section or any part of this ordinance shall be subject, upon conviction, to a fine of not more than \$500 or imprisonment for not more than 90 days, or both, in the discretion of the Judge imposing the same.

§ 1-10. Severability of Code provisions.

This Code and the various parts, sections, subsections, paragraphs, sentences, phrases, and clauses thereof are hereby declared to be severable. If any part, section, subsection, paragraph, sentence, phrase, or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, it is hereby provided that the remainder of this Code shall not be affected thereby and shall remain in effect and valid.

§ 1-11. Severability of ordinance provisions.

Each section of this ordinance is an independent section, and the holding of any section or part thereof to be unconstitutional, void or ineffective for any cause shall not be deemed to affect the validity or constitutionality of any other sections or parts thereof.

§ 1-12. Repealer.

All ordinances or parts of ordinances of a general and permanent nature adopted and in force on the date of the adoption of this ordinance and not contained in the Code are hereby repealed as of the effective date of this Adopting Ordinance, except as hereinafter provided.

§ 1-13. Ordinances saved from repeal.

The adoption of this Code and the repeal of ordinances provided for in § 1-12 of this ordinance shall not affect the following ordinances, rights and obligations, which are hereby expressly saved from repeal. The ordinances or portions of ordinances designated below continue in full force and effect to the same extent as if published at length in this Code.

- A. Any ordinance adopted subsequent to December 13, 2021.
- B. Any ordinance or portion of any ordinance promising or guaranteeing the payment of money or authorizing the issuance of bonds or other instruments of indebtedness.
- C. Any ordinance or portion of any ordinance authorizing or approving any contract, deed, or agreement.
- D. Any ordinance or portion of any ordinance granting any right or franchise.
- E. Any ordinance or portion of any ordinance making or approving any appropriation or budget.
- F. Any ordinance or portion of any ordinance providing for salaries or other employee benefits or personnel policies not codified in this Code.
- G. Any ordinance or portion of any ordinance levying, imposing, or otherwise relating to taxes not codified in this Code.

Charter Township of Allendale, Michigan

- H. Any ordinance or portion of any ordinance adopting or amending the Charter Township Master Plan.
- I. Any ordinance or portion of any ordinance dedicating, accepting, or vacating any plat or subdivision.
- J. Any ordinance or portion of any ordinance dedicating, establishing, naming, locating, relocating, opening, paving, widening, repairing, or vacating any street, sidewalk, or alley.
- K. Any ordinance or portion of any ordinance establishing the grade of any street or sidewalk.
- L. Any ordinance or portion of any ordinance levying or imposing any special assessment.
- M. Any ordinance rezoning property.
- N. Any ordinance regarding special districts.
- O. Any ordinance or portion of any ordinance that is temporary although general in effect.
- P. Any ordinance or portion of any ordinance that is special although permanent in effect.
- Q. Any ordinance or portion of any ordinance the purpose of which has been accomplished.
- R. Any Charter Township ordinance (or portions thereof) adopted by reference and not fully incorporated or restated within this Code.
- T. The Zoning Ordinance of the Charter Township of Allendale, as amended.

§ 1-14. Provisions deemed continuation of existing ordinances.

The provisions of this Code, insofar as they are substantially the same as ordinances previously adopted by the Charter Township relating to the same subject matter, shall be construed as restatements and continuations thereof and not as entirely new enactments.

§ 1-15. Effect on prior offenses or rights.

- A. Nothing in this Code (or the ordinance adopting this Code) affects any offense or act committed or done, any penalty or forfeiture incurred, or any contract or right established before the effective date of this Code.
- B. The adoption of this Code does not authorize any use or the continuation of any use of a structure, building, or premises in violation of any Charter Township ordinance on the effective date of this Code.

§ 1-16. Changes in previously adopted ordinances.

- A. In compiling and preparing the ordinances for adoption and revision as part of the Code, certain grammatical changes and other minor changes were made in one or more of said ordinances. It is the intention of the Township Board that all such changes be adopted as part of the Code as if the ordinances so changed had been previously formally amended to read as such.
- B. Global revisions; nomenclature changes.
 - (1) Throughout the Code, references to MSA are deleted.
 - (2) References to the Department of Environmental Quality (DEQ) are changed to refer insstead to the Department of Environment, Great Lakes, and Energy (EGLE).
 - (3) References to the Subdivision Control Act are changed to instead refer to the Land Division Act.
- C. The changes, amendments or revisions as set forth in Schedule A attached hereto and made a part hereof are made herewith, to become effective upon the effective date of this ordinance. (Chapter and section number references are to the ordinances as they have been renumbered and appear in the Code.)

§ 1-17. References to Michigan Compiled Laws.

- A. Throughout the Code, a reference to "Michigan Compiled Laws" shall include all sections of law, as last amended, which are assigned a compilation number by the legislative service bureau and are not subsequently repealed.
- B. Unless otherwise specifically provided, a reference to all or part of a statute, regardless of whether the words "as amended" are used in the reference, shall include the latest amendments to the statute or part.

1-18. Liability.

No officer, agent, or employee of the Township or member of the Township Board shall render himself or herself personally liable for any damage which may occur to any person or entity as the result of any act or decision performed in the discharge of his or her duties and responsibilities pursuant to this ordinance or the Code adopted hereby.

Chapter 167, Construction Codes.

Article I, Electrical Code Enforcement.

Section 167-4A is amended to read as follows:

In addition to any charges, fines or penalties for which a person may be liable under other applicable law or local ordinances, any person who violates, disobeys, omits, neglects or refuses to comply with, or resists enforcement of the Electrical Code within the boundaries of the Township shall be responsible for a municipal civil infraction, subject to Chapter 35, Municipal Civil Infractions.

Article II, Mechanical Code Enforcement.

Section 167-8A is amended to read as follows:

In addition to any charges, fines or penalties for which a person may be liable under other applicable law or local ordinances, any person who violates, disobeys, omits, neglects or refuses to comply with, or resists enforcement of the Mechanical Code within the boundaries of the Township shall be responsible for a municipal civil infraction, subject to Chapter 35, Municipal Civil Infractions.

Article III, Plumbing Code Enforcement.

Section 167-12A is amended to read as follows:

In addition to any charges, fines or penalties for which a person may be liable under other applicable law or local ordinances, any person who violates, disobeys, omits, neglects or refuses to comply with, or resists enforcement of the Plumbing Code within the boundaries of the Township shall be responsible for a municipal civil infraction, subject to Chapter 35, Municipal Civil Infractions.

Article IV, Building and Residential Code Enforcement; Flood-Prone Hazard Areas.

A. Section 167-15 is amended to change the date "5-16-2013" to "10-10-2021."

B. Section 167-17A is amended to read as follows:

In addition to any charges, fines or penalties for which a person may be liable under other applicable law or local ordinances, any person who violates, disobeys, omits, neglects or refuses to comply with, or resists enforcement of this article within the boundaries of the Township shall be responsible for a municipal civil infraction, subject to Chapter 35, Municipal Civil Infractions.

Chapter 178, Disorderly Conduct.

Section 178-2 is amened as indicated: "...upon conviction thereof, shall <u>be guilty of a</u> <u>misdemeanor and shall be</u> punished by a fine not exceeding..."

Chapter 188, Drugs and Tobacco.

Article I, Drug Paraphernalia.

Original Section 4(4), which regarded items which may be used to prepare or smoke tobacco or other smoking herbs other than controlled substances, is repealed.

Article II, Marihuana Facilities and Establishments.

- C. Section 188-5B is amended as indicated: "...Michigan Initiated Law 1 of 2008, MCL 333.26421 et seq., or as reflected in Section 1 of this Ordinance."
- D. Section 188-6A is amended to read as follows:

In addition to any charges, fines or penalties for which a person may be liable under other applicable law or local ordinance, any violation of, refusal to comply with, or resistance to the enforcement of this article shall be a municipal civil infraction, subject to Chapter 35, Municipal Civil Infractions.

Article III, Alternative Nicotine Products and Vapor Products.

Section 188-10A is amended to read as follows:

In addition to any charges, fines or penalties for which a person may be liable under other applicable law or local ordinance, any violation of, refusal to comply with, or resistance to the enforcement of this article shall be a municipal civil infraction, subject to Chapter 35, Municipal Civil Infractions.

Chapter 199, Emergency Services Cost Recovery.

In § 199-2, the definition of "hazardous materials" is amended to change "MCLA 299.601 et seq." to "MCLA § 324.20101 et seq."

Chapter 230, Fire Prevention.

Article I, Fireworks.

- A. Section 230-2C(2) is amended as indicated: "...influence of alcoholic liquor, marijuana, a controlled substance..."
- B. In § 230-3C:
 - (1) Subsection C itself is amended as indicated: "...fireworks as described by MCL MCLA750.243a must meet all requirements of Chapter 39 of Michigan PA 328 of 1931, as amended, and this ordinance in MCLA 28.466(1) must meet all the requirements of Michigan Public Act 256 of 2011, MCLA § 28.451 et seq. The following is the minimum..."

Chapter 300, Parks and Recreations Areas.

In addition to any charges, fines or penalties for which a person may be liable under other applicable law or local ordinances, any person who violates, disobeys, omits, neglects or refuses to comply with, or resists enforcement of this article within the boundaries of the Township shall be responsible for a municipal civil infraction, subject to Chapter 35, Municipal Civil Infractions.
