ALLENDALE CHARTER TOWNSHIP SEWER SYSTEM AMENDMENT ORDINANCE REGARDING RATE SCHEDULE

Ordinance No. 2013-12

AN ORDINANCE to amend Ordinance No. 2006-26, the Sewer System Ordinance of the Charter Township of Allendale, Ottawa County, Michigan, to permit the rate schedule to be adopted by resolution of the Township Board from time to time, to provide for other matters relative to the use of the Township sewer system; and to provide for the effective date of this Ordinance.

THE CHARTER TOWNSHIP OF ALLENDALE, COUNTY OF OTTAWA, STATE OF MICHIGAN, ORDAINS:

- Section 1. <u>Title</u>. This Ordinance shall be known as and may be cited as the "Charter Township of Allendale Sewer System Rate Ordinance Amendment."
- Section 2. <u>Definitions</u>. Subsection 2(b) of the Charter Township of Allendale Sewer System Ordinance shall be amended to state in its entirety as follows:
 - (b) "Rate Schedule" means the schedule of rates and charges as may be established by resolution adopted by the Township Board from time to time.
- Section 3. <u>Sewer Rates</u>. Section 8 of the Charter Township of Allendale's Sewer System Ordinance shall be amended to state in its entirety as follows:
 - Section 8. Sewer Rates. Rates for services provided by the System to each premises connected to the System for the charges's described in this Ordinance shall be determined by the Township Board and shall be established by resolution adopted and amended by the Township Board from time to time. No free service shall be furnished by the System to the Township or to any person, firm or corporation, public or private, or to any public agency or instrumentality. The Township shall pay for sewer discharged by

the Township or by any of its departments or agencies at the rate established pursuant to this Section.

Section 4. Repeal. All ordinances or parts thereof which are in conflict in whole or in part with any of the provisions of this Ordinance as of the effective date of this Ordinance, including, but without limitation, Ordinance No. 2006-26, are hereby repealed to the extent of such conflict.
