ALLENDALE CHARTER TOWNSHIP WATER SYSTEM AMENDMENT ORDINANCE REGARDING RATE SCHEDULE

Ordinance No. 2013-11

AN ORDINANCE to amend Ordinance No. 1981-3, as amended, the Water System Ordinance, of the Charter Township of Allendale, Ottawa County, Michigan, adopted by Allendale Charter Township, to permit the establishment of rates pursuant to resolution, to provide for other matters relative to the use of the Township Water System; and to provide for the effective date of this Ordinance.

ALLENDALE CHARTER TOWNSHIP, COUNTY OF OTTAWA, AND STATE OF MICHIGAN ORDAINS:

- Section 1. <u>Title</u>. This Ordinance shall be known as and may be cited as the "Charter Township of Allendale Water System Rate Ordinance Amendment."
- Section 2. <u>Definitions</u>. Subsection 2(b) of the Charter Township of Allendale Water System Ordinance shall be amended to state in its entirety as follows:
 - (b) "Rate Schedule" means the schedule of rates and charges as may be established by resolution adopted by the Township Board from time to time.
- Section 3. <u>Water Rates.</u> Section 8 of the Charter Township of Allendale Water System Ordinance shall be amended to state in its entirety as follows:
 - Section 8. Water Rates. Rates for water supplied to each premises connected to the System and for the charges described in this Ordinance, shall be determined by the Township Board and shall be established by a resolution adopted and amended by the Township Board from time to time. No free service shall be furnished by the System to the Township or to any person, firm or corporation, public or private, or to any public agency or instrumentality, with the exception that no water charge shall be made to a customer for the water used to test a standby fire line connection or to fight a

fire on the premises. The Township shall pay for water supplied to it or any of its departments or agencies at any rates established pursuant to this Section. In addition, the Township shall pay for the water use for fire hydrants, fire protection or other purposes at the rates established pursuant to this Section.

Section 4. Repeal. All ordinances or parts thereof which are in conflict in whole or in part with any of the provisions of this Ordinance as of the effective date of this Ordinance, including, but without limitation, Ordinance No. 1981-3, as amended, are hereby repealed to the extent of such conflict.

Section 5. <u>Effective Date.</u> This Ordinance was approved and adopted by the Township Board of the Charter Township of Allendale, Ottawa County, Michigan, on June 24, 2013, after introduction and a first reading on June 10, 2013, and publication after first reading as required by Act 359 of the Michigan Public Acts of 1947, as amended. This Ordinance shall be effective on June 29, 2013.
