

The following Zoning Text Amendment Ordinance was introduced and a first reading completed at the Allendale Charter Township Board meeting on May 28, 2019.

ORDINANCE NO.2019-8

**A ZONING TEXT AMENDMENT ORDINANCE TO AMEND THE ZONING ORDINANCE
OF THE CHARTER TOWNSHIP OF ALLENDALE**

[Complete Prohibition of Marihuana Facilities/Establishments]

THE CHARTER TOWNSHIP OF ALLENDALE, OTTAWA COUNTY, STATE OF MICHIGAN ORDAINS:

Section 1. **Prohibition of Marihuana Facilities/Establishments.** Chapter 3 of the Zoning Ordinance for Allendale Charter Township (the “Zoning Ordinance”) is hereby amended by adding Section 3.18, which shall state in its entirety as follows:

SECTION 3.18 MARIHUANA FACILITIES AND ESTABLISHMENTS PROHIBITED

- A. The following uses are completely prohibited in the Township, and may not be established or operated in any zoning district, by any means, including by way of a variance:
 - (1) Any and all types of a “marihuana establishment,” as that term is defined and used in Michigan Initiated Law 1 of 2018, commonly known as the Michigan Regulation and Taxation of Marihuana Act.
 - (2) Any and all types of a “marihuana facility,” as that term is defined and used in the Medical Marihuana Facilities Licensing Act, MCL 333.27101, *et seq.*

- B. This Section 3.18 does not limit any privileges, rights, immunities or defenses of a person as provided in the Michigan Medical Marihuana Act, Michigan Initiated Law 1 of 2008, MCL 333.26421, *et seq.*

Section 2. **Effective Date.** This Amendment to the Allendale Charter Township Zoning Ordinance was approved and adopted by the Township Board of Allendale Charter Township, Ottawa County, Michigan on June 10, 2019, after a public hearing as required pursuant to Michigan Act 110 of 2006, as amended; after introduction and a first reading on May 28, 2019, and after posting and publication following such first reading as required by Michigan Act 359 of

1947, as amended. This Ordinance shall be effective on July 1, 2019, which date is the eighth day after publication of a Notice of Adoption of the Recreational Marihuana Zoning Ordinance Amendment in the Sunday Edition of the Grand Rapids Press as required by Section 401 of Act 110, as amended. However, this effective date shall be extended as necessary to comply with the requirements of Section 402 of Act 110, as amended.
