ZONING MAP ORDINANCE AMENDMENT**

**APPLICANT: STONE CREEK ALLENDALE, LLC**

An Ordinance to amend certain portions of the Zoning Ordinance and Map of Allendale Charter Township, Ottawa County, Michigan for the purpose of rezoning certain lands from the R-1, Low Density One-Family Residential District to the C-2, General Commercial District.

**THE CHARTER TOWNSHIP OF ALLENDALE, COUNTY OF OTTAWA, AND STATE OF MICHIGAN ORDAINS:**

**SECTION 1. Rezoning to C-2 General Commercial District.**

The Zoning Ordinance and Map of the Charter Township of Allendale, Ottawa County Michigan, which map is incorporated by reference in the Zoning Ordinance for the Charter Township of Allendale, pursuant to Section 4.02, shall be amended so that hereafter the lands described below within this Zoning Map Amendment shall be zoned and included in the C-2 General Commercial District on said Zoning Map. The property being rezoned to the C-2 General Commercial District from the R-1, Low Density One-Family Residential District is described as follows:
